WARRANTY CARD

TECH STEROWNIKI II Sp. z o.o. company ensures to the Buyer proper operation of the device for the period of 24 months from the date of sale. The Guarantor undertakes to repair the device free of charge if the defects occurred through the manufacturer's fault. The device should be delivered to its manufacturer. Principles of conduct in the case of a complaint are determined by the Act on specific terms and conditions of consumer sale and amendments of the Civil Code (Journal of Laws of 5 September 2002).

CAUTION! THE TEMPERATURE SENSOR CANNOT BE IMMERSSED IN ANY LIQUID (OIL ETC). THIS MAY RESULT IN DAMAGING THE CONTROLLER AND LOSS OF WARRANTY! THE ACCEPTABLE RELATIVE HUMIDITY OF THE CONTROLLER'S ENVIRONMENT IS 5÷85% REL.H. WITHOUT THE STEAM CONDENSATION EFFECT. THE DEVICE IS NOT INTENDED TO BE OPERATED BY CHILDREN.

Activities related to setting and regulation of the controller parameters described in the Instruction Manual and parts wearing out during normal operation, such as fuses, are not covered by warranty repairs. The warranty does not cover damages arising as a result of improper operation or through the user's fault, mechanical damage or damage created as a result of fire, flood, atmospheric discharges, overvoltage or short-circuit. The interference of an unauthorized service, wilful repairs, modifications and construction changes cause the loss of Warranty. TECH controllers have protective seals. Removing a seal results in the loss of Warranty.

The costs of unjustifiable service call to a defect will be borne exclusively by the buyer. The unjustifiable service call is defined as a call to remove damages not resulting from the Guarantor's fault as well as a call considered unjustifiable by the service after diagnosing the device (e.g. damage of the equipment through the fault of the client or not subject to Warranty), or if the device defect occurred for reasons lying beyond the device.

In order to execute the rights arising from this Warranty, the user is obliged, at his own cost and risk, deliver the device to the Guarantor along with a correctly filled-in warranty card (containing in particular the sale date, the seller's signature and a description of the defect) and sales proof (receipt, VAT invoice, etc.). The Warranty Card is the only basis for repair free of charge. The complaint repair time is 14 days.

When the Warranty Card is lost or damaged, the manufacturer does not issue a duplicate.

Safety

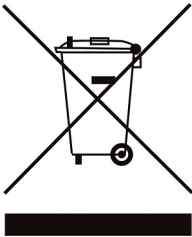

Description

The EU-STZ-180 RS actuator is used to control three-way and four-way mixing valves. It is controlled by a 3-point signal. The actuator has a manual control option accessed with use of a pull-out knob. It is also equipped with a display and a valve temperature sensor. The rotation range of the actuator is 90° and the rotation time is 180s.



The EU-STZ-180 RS actuator is supplied with an adapter that allows for its easy installation on the rotary mixing valve.



Operating

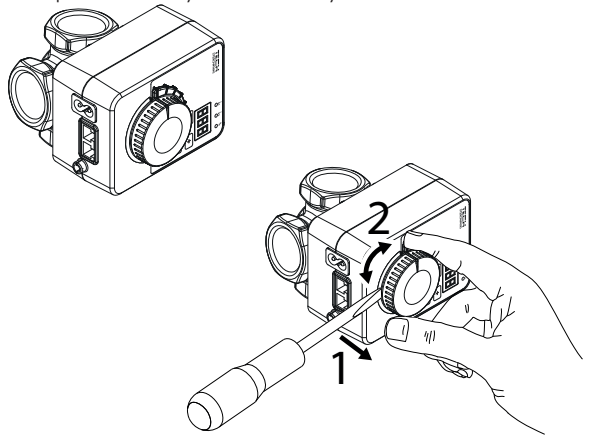
When the actuator is started, the programme number is displayed for 10 seconds. After this time, the displayed values for the set and current temperature and the percentage of valve opening change every 5 seconds. When calibrating the valve, instead of the percentage value of the valve opening, **CAL** will be displayed.

Use the MENU button to enter the menu function. Switching parameters of the menu functions is done using the PLUS and MINUS buttons. To edit the selected parameter, use the MENU button.

MENU functions:

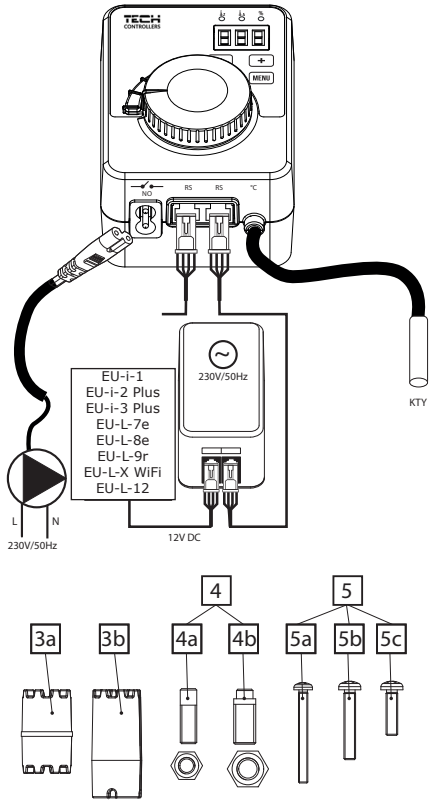
- ON/OFF** - current valve status: ON or OFF
- t. CH/t. FL** - valve type: CH or Floor (FL)
- d.L/d.r** - change valve opening direction
- FAC** - restore the factory settings (hold the MENU button for approx. 3 secs.)
- Ot** - manual operation functions
- E---** - exit from the menu
- OP** - set the minimum valve opening (0-99)
- Int** - set the measurement pause

The auxiliary switch (set to any position) is available as pre-installed equipment or as optional equipment. After removing the knob under which the cam is located, adjusting the auxiliary switch is easy and does not require disassembly or the use of any tools.

Use

Thanks to the special clutch between the EU-STZ-180 RS actuator and the mixing valves, the whole set is characterized by exceptional stability and precision of adjustment.

The EU-STZ-180 RS actuator operate with the following valves:

MANUAL OPERATION functions :

To enter the manual operation function menu, find „Ot” in the function menu and confirm with the MENU button. Then use the PLUS/MINUS buttons to navigate through the menu of the manual operation function. Changes of individual parameters can be confirmed by pressing the MENU button.

- 0/1 .P** - Valve pump
- 0/1 .O** - Opening
- 0/1 .C** - Closing
- E---** - exit from the menu

The valve setpoint temperature screen alternates between the setpoint and current temperature and the percentage of valve opening. To edit the set temperature, use the PLUS/MINUS buttons until the temperature starts to change.

Registration

The EU-STZ-180 RS actuator can operate independently or (following the registration process) via the main controller. Depending on the connected controller, its operating functions can be extended.

A detailed description of the registration process is found in the manual of the main controller.
